## 25 YEAR UNICLIC 8mm STEPS PLANKS WARRANTY TORLYS UNICLIC LAMINATE FLOORS

### WEAR WARRANTY

All Torlys **Uniclic 8mm Steps Plank** products are covered by a 25 Year Residential Wear, Fade, Stain & Water Penetration Warranty and are free from manufacturing defects. This warranty applies only to the original purchaser of the product for residential use applications and is not transferable. This warranty applies to all first grade **Uniclic 8mm Steps Planks Flooring** brand product purchases made after January 1, 2001

If the product wears through, fades, stains or is damaged by surface water during the warranty period, Torlys will repair or replace the product, at its option.

### NOTE

**STEPS UNICLIC is not recommended for extreme humid applications such as in saunas or swimming pool areas.**

### IMPORTANT

**This warranty is only valid if proper maintenance procedures are followed. Check with Torlys for detailed information.**

### CONDITIONS

The **25 Year Uniclic 8mm Steps Planks Warranty** is subject to the following conditions:

1. The **Uniclic 8mm Steps Planks** product must be installed following the **UNICLIC 8mm STEPS Planks** installation method (including full perimeter silicone sealant in wet areas such as bathrooms) using the approved **UNICLIC STEPS** accessories.

2. The **UNICLIC 8mm STEPS Planks** product must be installed indoors in a residential application.
3. The surface wear must be evident, measuring at least one square inch and must not be the result of abusive conditions or accidents, such as but not limited to damage caused by severe impact, scratching or cutting.
4. The surface water warranty is only valid for residential applications and excludes damage caused by natural disasters, natural cause elements or flooding.

### EXCLUSIONS

The following are expressly excluded from the present guarantee:

1. Defects or damage caused by installation that does not comply with **Uniclic 8mm Steps Planks Flooring** recommended installation procedures. Any failure, as a result of improper installation, is the sole responsibility of the flooring contractor and/or installer.
2. Inadequate product choice for the flooring use conditions.
3. Damage due to improper maintenance; refer to Torlys **Uniclic 8mm Steps Planks Flooring Maintenance Instructions** or call Torlys Inc. for recommended products.
4. Unapproved modification or repair.
5. Damage due to exposure to excessive heat, cold or dryness (It is recommended that the relative humidity in a home stay in the healthy range of 40-60% throughout the year. To accomplish this, it may require the use of a de-humidifier or a humidifier depending on the condition.).
6. Accidents or misuse.
7. Labor on material installed with obvious visual defects.

### HOW TO MAKE A CLAIM

1. Notify the retailer who sold you the material promptly, in writing. You must supply proof of purchase. Include the product name, quantity involved and installation costs (if applicable).
2. Once the retailer verifies the claim, he will then notify a Torlys representative, and, if necessary, an inspection will be arranged. If you are unable to contact your dealer or are not satisfied with the dealer's recommendation, please contact Torlys at: 1.800.461.2573.
3. If a defect is verified, Torlys will arrange for the repair or replacement of the defective floor; if the floor needs to be replaced, the replacement material will be the same design and coloration as the original. If the original flooring is no longer available, then other

Torlys **Uniclic 8mm Steps Planks Flooring** product of equal value will be supplied. Torlys will repair or replace a floor one time during the life of its warranty.

Torlys Inc. excludes and will not pay consequential damages under this warranty. Repair or replacement of flooring material is the sole remedy. This warranty includes the cost of labor of professional installations only, of the replacements of the defective floor boards only.

There are no other warranties, including merchantability or fitness for a particular purpose, expressed or implied other than the one listed within this warranty. This warranty shall not deem to have failed its essential purpose while Torlys Inc. is willing to repair or replace defective goods.
